October 9, 2008 Meeting Minutes - Telephone Conference Call

President Chad Kremer called the meeting to order. Present were board members John Cammack, Nancy Hepper, Larry Carr, Bruce Anderson and executive director, Karen Conley.

The board reviewed the association financials. It was decided at this time, due to the volatility of the market, to not replace the \$10,000 that was borrowed from the UBS account back into that account. The money is currently being held in the association savings account. Conley will check with the bank to find out if there is any limit on the amount we can have in savings or about putting some of the funds into a short term CD. There being no further questions or comments about the Treasurer's Report, Anderson made a motion to accept the Treasurer's Report. Cammack seconded the motion. Motion carried.

President Kremer updated the board as to our status with the Black Hills Stock Show. They are waiting to find out what the DTBA is going to do with regard to the additional consignment auction. Once a design has been made, a meeting will be set with the BHSS group to go over our plans.

There was discussion about the issue of testing for the two different live animal auctions. All agreed that testing should be the same and it was decided to require 3-way testing (Brucellosis, Anaplasmosis and Tuberculosis) for all animals being sold during our event.

The second judge for the live animal show was discussed. A list of potential judges was created and Conley will contact those on the list to secure the second judge for the show.

The consignment auction was discussed. There was a great deal of input from the sale committee on formats and various class groupings. The board made a decision to limit this first consignment auction to calves only. It will be marketed as a premium calf auction, designed to allow as many producers as possible to showcase a selection of their calf crop. Producers will be encouraged to bring a representative group of their calf crop to put in front of prospective buyers. This will allow for a much greater exposure to a wide range of buyers.

The calf consignment auction will be structured as follows: Each producer can bring a limit of 20 head of calves. They can bring up to two lots, depending on how many of each bulls or heifers they

choose to bring. Minimum lot size is 10 head, so a producer could, for example, bring 10 head each of bull and heifer calves. Or 20 head of bull calves or 20 head of heifer calves, etc. The association will create a catalog with a short bio for each consignor so they can give information about how many more calves they have back home or whatever they choose to advertise about their program. Contact information, program information, etc. will be in the catalog which will be designed as a resource for buyers.

There will be no changes to the Reality Based Carcass Class for 2009. It was suggested that it might be a good time to have Bruce Anderson do another presentation about this class to the attendees at the winter conference.

The Young Guns Bull Challenge is set for this year with 18 entries in the first group. During the 2009 conference, time will be set aside for anyone interested in this class to meet and explore the idea of entering two animals, one in the live show and one in the carcass class in 2010.

Need to start lining up sponsorships for 2009. Conley will provide a list and costs to the board members so we can begin rounding up the sponsorships.

The group discussed ideas for the winter conference. Suggestions including Kit Pharo and perhaps some Canadian producers. No solid plans were made at this time.

There was an offer from the Rocky Mountain Buffalo Association to participate with them in a Producer Seminar next fall. The weekend of September 19, 2009 will be set aside and interested parties will be meeting at Boyd Meyer's ranch in Cheyenne, Wyoming for a Producer Seminar and Ranch Tour. The board was very excited about this and discussion included renting a bus or two to take down to the meeting and perhaps having current producers sponsor a new producer for the event. The group could even tour a ranch or two on the way to or from the meeting. The board decided this would be a good idea to pursue and Anderson will let Boyd Meyer know the DTBA would like to participate in this event.

There being no further business, Hepper made a motion to adjourn the meeting. Anderson seconded the motion. Meeting adjourned.

CARCASS CLASS ENTRY INFORMATION AND TERMS

1. Entry fee is \$300 per consignment. One entry per consignor in each class.
2. All entries will be mouthed when they arrive at Western Buffalo Company on the slaughter date. On that date, only bulls with all their baby teeth will be accepted and heifers can not have more than two permanent teeth.
3. PLEASE NOTE: The minimum weight for bull carcasses will be 550 pounds. The minimum weight for heifer carcasses will be 435 pounds. Please keep this in mind as you select animals to bring to the contest. Carcasses not meeting the minimum weight requirements will be disqualified from the contest and there will be no entry fee refund. Western Buffalo Company has agreed to purchase those carcasses at an approximate price of \$2.45 for bulls and \$2.35 for heifers, depending on the market, or the consignor may pay the processing fee and take the meat home. All other terms and conditions relating to the carcasses will still apply to those that are disqualified from the contest.
4. No health papers are needed on the animals participating in the Carcass Class.
5. Bulls and heifers will be delivered live to Western Buffalo Company in Rapid City, SD on Wednesday, January 14, 2009 only. Please be aware that, given the work schedule at Western Buffalo Company, the association is trying to work within a set time frame. We will be able to process all entries in one day.
6. South Dakota State University and a State Inspector will be on hand to oversee the testing of the meat cuts. All cuts will be trimmed to 1/4" fat cover and the ground buffalo will be tested for fat content and a sliding scale for value of product will be set up.
7. All buffalo will be boxed separately and frozen. Cut test sheets on each carcass will be developed showing how the cuts or group of cuts affect the bottom line.
8. The winner of the Carcass Class will be the buffalo that yields the most percentage of profit.
9. The winning carcasses will become the property of the Dakota Territory Buffalo Association and will be purchased by Western Buffalo Company with the proceeds going to the association.
10. The ribeye from ALL carcass class entries is donated and will be used as the main entree at the DTBA Awards Banquet during our Winter Conference.
