#### HEALTH REQUIREMENTS FOR ALL INCOMING BULL ENTRIES

1. Consignors are responsible for all testing & paperwork to export to South Dakota.
  2. All Bulls will be required to test: TB, Brucellosis, Trichomoniasis, & Passed Semen Test
  3. All animals must have an acceptable EID or metal ID that correlates with their Sale ear tag and both numbers must be noted on the health papers.
  4. All animals must be delivered to the Muley Hills Arena, Deadwood, SD by 6 pm Thursday, Feb 5th 2026. All catalog photos and videos will be professionally done Friday morning, Feb 6th 2026 to ensure a 24 hour online promotion of animals - missing this delivery deadline may mean photos not making the catalog.

#### EAR TAGS

All entries need to be delivered with sale ear tags to individually identify animals as well as an official USDA tag (EID or Metal).

#### ENTRY LIMITS AND DEADLINES

There will be a limit of 2 bull entries per consignor. **Payment in full of \$1000 per head must accompany the entry form or it will not be accepted.**

- Auctioneer Commission
- Full page Ranch Bio in Show & Sale Catalog
- Marketing of consignor ranches leading up to show & sale
- Trophies for 1st, 2nd, 3rd places
- Awards for top buyer & top seller
- Feed, Pens, & care of animals from 5pm Feb 5th to load out Sunday, Feb 8th

Animals will be accommodated from 5 pm on Thursday Feb 5th to load out on Sunday, Feb 8th  
Judging will be on Friday, Feb 6th from noon - 5 pm and the sale on Saturday, Feb 7th 2026.

1. Animals entered into the 2026 Black Hills Buffalo Thunder will be delivered as per instructions on the entry form with health paperwork being given at time of delivery.
2. **NEW** Live Judging will be performed onsite Friday, Feb 6th 2026 from noon-5 pm. The scoring will be based on conformation - all consignors will be provided with scoring rubric per the judges upon registration. The results will be announced prior to the sale Saturday, Feb 7th 2026.
3. Any death loss incurred at any time during the course of Black Hills Buffalo Thunder is at the consignor's own risk and no compensation will be given for any reason. All entry fees are non-refundable (unless class is overfilled and consignors are asked to scale back entries) and non-negotiable.
4. All auction animals will sell individually. All animals will be sold by video/photo only and will not be run through the sale ring.

**LIABILITY**

1. The consignor assumes all responsibilities in regards to, but not limited to, the above terms and conditions of this show and sale. The DTBA acts only as agents and will assume NO responsibility in the event of injury or death to any animal or for any discrepancy between the buyers and the consignors. Any death loss incurred at any time during the course of Black Hills Buffalo Thunder is at the consignor's own risk and no compensation will be given for any reason. All entry fees are non-refundable and non-negotiable.
2. The Judges and/or Show Committee, Sifting Committee (appointed by the DTBA Board of Directors and the Show Chairman) reserve the right to inspect any animals and may ultimately disqualify/remove any animals for any reason they deem necessary. Committee decisions are final.
